Consistent with Georgia EPD, non-detectable effluent concentrations are not translated into Calculated Receiving Water Concentrations.

 5 Numeric Water Quality Criteria is the maximum concentration of a parameter (calculated at a default hardness on poll, as a calcium carbonate) established for the receiving waterbody that will be protective of the designated use per Georgia EPD's rules and regulations. Calculated Receiving Water Concentrations less than these criteria are protective of the waterbody.
