ND = Not Detected (below the lab's reporting limit).

Turbidity and total residual chlorine are monitored continuously. The value reported is the weekly maximum and the daily average is the average of the weekly maximum values reported.

This value is calculated as a dissolved concentration for an appropriate comparison to the numeric water quality criteria, which are also in the discharge of the weekly maximum values reported.
