- 3 ND = Not Detected. ND = Not Detected (below the lab's reporting limit).
- 4 Calculated Receiving Water Concentration shows the effluent concentration at the discharge once it has fully mixed in the receiving waterbody. This value is calculated as a dissolved concentration for an appropriate comparison to
- the numeric water quality criteria, which are also in the dissolved form. Consistent with Georgia EPD, non-detectable effluent concentrations are not translated into Calculated Receiving Water Concentrations.

  Numeric Water Quality Criteria is the maximum concentration of a parameter (calculated at a default hardness of 50 mg/L as calcium carbonate) established for the receiving waterbody that will be protective of the designated use per Georgia EPD's rules and regulations. Calculated Receiving Water Concentrations less than these criteria are protective of the waterbody.
- 6 Acute (short-term) water quality criterion to be compared with the weekly calculated receiving water concentration; Chronic (long-term) water quality criterion to be compared with the average calculated receiving water concentration.
- 7 Numeric water quality criterion shown is for Hexavalent Chromium.
