AVAILABILITY:

Throughout the Company's service area from existing lines of adequate capacity. All customers on this tariff must have Automated Metering Infrastructure (AMI) with reconnect/disconnect functionality and acceptable network coverage.

APPLICABILITY:

For all domestic uses of a residential customer in a separately metered dwelling unit, with the exception of customers who have health or safety risks associated with the loss of service. A residential customer hereunder is defined in the Company's Rules and Regulations for Electric Service.

Applicable to residential customers who have been in their current residence and have had their electricity priced on a residential tariff over the previous 12 months.

TYPE OF SERVICE:

Single phase, 60 hertz, at a standard voltage.

TERM OF CONTRACT:

Service hereunder shall be for a period of one year. All eligible Pay by Day offers will be updated at the end of the contract using the previous years' consumption. Contracts will automatically renew for the following year, unless the customer notifies the Company otherwise.

DAILY PRICE FORMULA:

- Monthly Amount** = [Expected Monthly Usage * Usage Charges * (1+ Risk Adder %)]
+ Basic Service Charge + applicable taxes
- Annual Amount** = Sum of the 12 monthly amounts
- Pay by Day Daily Price** = Annual Amount / number of days in the contract period
- Minimum Daily Charge** = Pay by Day daily price

DEFINITIONS:

Expected Monthly Usage - Customer's expected monthly energy consumption is calculated based on the customer's historical metered usage adjusted for normal weather and consumption changes in customer behavior.

Usage Charges – The energy charges from the Pre-Pay Service (PPS) schedule including Environmental Compliance Cost Recovery (ECCR), Nuclear Construction Cost Recovery (NCCR), Demand Side Management Residential (DSM-R) and Fuel Cost Recovery (FCR) charges and other applicable schedules.

Risk Adder % -The adder is used to compensate Georgia Power for risks associated with weather-related consumption as well as the risk associated with non-weather impacts. This adder will not exceed 10%.

Basic Service Charge – As shown in the Pre-Pay Service (PPS) schedule: including ECCR charges, NCCR charges, DSM-R Schedule and other applicable schedules.

Normal Weather - Based on Georgia's seasonal heating degree-days and cooling degree-days.

ENVIRONMENTAL COMPLIANCE COST RECOVERY:

The daily amount calculated under this tariff includes the provisions of the Company's effective Environmental Compliance Cost Recovery Schedule, including any applicable adjustments.

NUCLEAR CONSTRUCTION COST RECOVERY:

The daily amount calculated under this tariff includes the provisions of the Company's effective Nuclear Construction Cost Recovery Schedule, including any applicable adjustments.

DEMAND SIDE MANAGEMENT SCHEDULE:

The daily amount calculated under this tariff includes the provisions of the Company's effective Demand Side Management Residential Schedule, including any applicable adjustments.

FUEL COST RECOVERY:

The daily amount calculated under this tariff includes the provisions of the Company's effective Fuel Cost Recovery Schedule, including any applicable adjustments.

MUNICIPAL FRANCHISE FEE:

The daily amount calculated under this tariff includes the provisions of the Company's effective Municipal Franchise Fee Schedule, including any applicable adjustments.

INCOME-QUALIFIED SENIOR CITIZEN DISCOUNT:

Qualifying customers certified by the Company will be eligible for a senior citizen discount based upon the definitions found in the Residential Service and Fuel Cost Recovery Schedules. The discount will be applied as a daily credit to customer accounts.

GENERAL TERMS & CONDITIONS:

By selecting the Pay by Day Service, customer acknowledges that Georgia Power Company Rules and Regulations E5, E6, E12 and F3 do not apply, or are modified as described below:

Disconnection and Reconnection: Service will be disconnected when the pre-paid balance drops to \$0.00, or as soon as feasible, and will not be reconnected until the pre-paid balance is made positive. The Company shall determine the appropriate minimum payment to restore service and this payment shall include all service used during the time that the account balance went to \$0.00 and the time of actual disconnection along with any reconnect fees described in Georgia Power Company Rule F3 for all disconnections upstream of the meter plus a minimum \$5.00 pre-payment to be used for future service. Upon receiving the required minimum payment, the Company will reconnect service as soon as feasible.

Late Payment Charge: The entire outstanding balance, including previous Late Payment Charges, is subject to E12 of the Company's Rules and Regulations.

Minimum positive balance for initial connection of Pay by Day: \$40.00. When applicable, the Account Establishment Charge as defined in E2 of the Company's Rules and Regulations and any other charges shall be added to and collected prior to service being connected.

A customer who withdraws from the program prior to the end of the 12-month contract period may be required to pay an additional amount. Specifically, the difference between the amount of electricity such customers actually used priced under the "Pre-Pay" tariff and the amount for which they have been billed under the "Pay by Day" tariff. Customers will not receive any refund or credit for amounts paid under the "Pay by Day" tariff if the amount of electricity actually used results in a billing amount under the "Pre-Pay" tariff that is less than the amount for which such customers have been billed.

If a customer's monthly usage as compared to the same month in the previous year, excluding the effects of weather, is 50% greater, then the Company may return the customer back to the traditional tariff for the remaining months of the "Pay by Day" contract. The return to the standard tariff will operate under the same provision concerning customer withdrawals as stated above.

The amount calculated under this tariff is subject to change in such an amount as may be approved and/or amended by the Georgia Public Service Commission under the provisions of applicable riders and other schedules. The amount calculated under this tariff is also subject to change in such an amount as may be required to properly collect the applicable taxes associated with electric service.
